**RESOLUTION AUTHORIZING STARFIRE CORPORATION TO
HOLD A FIREWORKS DISPLAY FOR A PRIVATE EVENT AT
THE MIDDLESEX COUNTY FAIRGROUNDS**

WHEREAS, Starfire Corporation has requested permission to display fireworks for two private special events at the Middlesex County Fairgrounds on October 9, 2021 and October 16, 2021 between 7:30 & 8:00 PM; and

WHEREAS, Starfire Corporation is authorized to display fireworks at the Middlesex County Fairgrounds as part of this special event, subject to approval by the Chief of Fire District #3 and the Township Fire Official, to insure the display is in accordance with all applicable laws in the State as outlined in the State Fire Prevention Code; and

WHEREAS, Starfire Corporation must provide the Township with its certificate of insurance in the amount of \$1,000,000 in accordance with the State Fire Prevention Code, N.J.A.C.5:70, F-3103.4.

NOW, THEREFORE, BE IT RESOLVED that the East Brunswick Township Council hereby gives its permission, contingent upon satisfaction of the above-referenced conditions, to Starfire Corporation to display fireworks in accordance with all applicable laws in the State Fire Prevention Code.
